• Roger explained County has jurisdiction from property line out to street, DSA has jurisdiction from property line into the school ground.

- Don Leatherman, our Inspector of Record, said grade from basketball to building not ADA compliant. County Parks and Rec will pay \$8,500; total cost will be \$13,000.
- Another additional, unfunded expense is tree removal for Monterey Pines, which are diseased and we have a permit; expected cost \$8,000.
- A portion of the \$77,698 spent in 2015 is included in the new Project Cost Analysis.
- 5. Report to Board: Andy made a presentation for the Report to Board. Discussion of whether replacing the IS classroom can be addressed under the Bond Project List "Miscellaneous District Projects including Address unforeseen conditions revealed by construction/modernization..." Eric said we should consider the question is if the school district went out for a bond in the future, how we handle the finances in accordance to the Bond. Costs will be divided approximately 2/3 to "approved" building, 1/3 to unapproved building.

Claudia pointed out the language is "The specific school facilities projects to be funded at Pacific School include, but shall not be limited to replacing roofs, computers and technology, renovate multi-purpose building, replace preschool". As an advisory committee to the board, it would be appropriate for us to ask the Principal/Superintendent to get an opinion from our attorney on retainer.

Claudia suggested Principal/ Superintendent *Eric Gross to ask* the attorney if the bond language could include the Smaller IS Classroom.
