*This Resolution authorizes bonds which allow for the compounding of interest.*

Background: The District's Measure I was approved by District voters on March 5, 2024, authorizing the District to issue general obligation bonds in the amount of up to \$1,300,000. The District has previously issued one series of bonds pursuant to Measure I. The Resolution for consideration begins the process of obtaining the second and final phase of Measure I financing, with the issuance of Series C Bonds in an amount up to \$760,000, to be used for capital projects approved by voters.

The resolution to be considered for adoption at the January 22, 2024, board meeting authorizes the Series B Bonds to be issued as current interest bonds and capital appreciation bonds. Under California law, when bonds that compound interest are proposed, the resolution must first be presented to the board as an informational item, and at the next meeting may be voted upon. Items required to be disclosed to the board relating to the bond structure are included in Appendix B to the Resolution.
