After discussion, the adoption, deletion, and tabling of the BPs and ARs noted above were approved. Mr. Croll moved, Ms. Napoles seconded. 2 in favor, 0 opposed, 0 abstentions, 1 absence.

#### 7.2. Rates for After Care and Recreation programs

Ms. Andrews presented some historical data relating to Rec, After Care, and Preschool enrollment, revenue and expenses. The Board discussed various options for changes to the After Care and Rec program and agreed to discuss it again at the next meeting.

# 7.3. Preschool Program Evaluation

The Board discussed various aspects of the preschool program:

Staffing: Mr. Gross reported that one of the preschool co-teachers will retire at the end of this year or next year. There are two existing staff members who are licensed preschool teachers and have expressed interest in the position whenever it becomes available.

Mr. Croll observed that based on the evaluations of the preschool, informal parent feedback, and personal experience, the existing staff are providing a strong program which encourages appropriate academic, social, and emotional development. Mr. Croll added that a change in staff due to retirement will create a need for appropriate and effective onboarding and training.

Curriculum: Mr. Gross observed that our preschool students arrive in kindergarten with the appropriate skills for being ready to learn.

Facilities: As discussed at last month's Board meeting, we are seeking funding opportunities that would allow us to replace the existing preschool building.

The Board discussed the pros and cons of extending preschool to full day. Pros include better serving a wider variety of families. Cons include new staffing needs and new and more complex requirements from the state preschool program.
