An email from Caitlin Phillips was received and reviewed by the board. Ms. Napoles provided background information around the fundraising associated with FoodLab and Farm-to-Table. Mr. Croll spoke about the importance of appreciating and supporting our volunteer community.

## 3. REPORTS

- 3.1. Superintendent Report
- Representatives from CalPoly and Pacific School met to discuss changes to make for future Farm-to-Table events. There are possibilities that CalPoly might provide student interns in FoodLab in the future.
- Transition from Digital Schools to Escape will require huge effort, mostly from the District Office Manager, Elizabeth Andrews.
- CA Connections Academy Charter will be visiting Pacific School.
- TIDES Non Public School closing next month = reduced SELPA costs
- Donors: \$50,000 (principal's discretion); \$1,000 for scholarships for after-school programs. The donors have pledged \$50,000 each year for 5 additional years for teacher empowerment. For this year about \$25,000 will be spent on FOSS science curriculum. Mr. Gross is working with other districts in the county to place a bulk order at a discount. The donation honors Stephanie and Chris Raugust. Mr. Croll urged Mr. Gross to do some strategic planning.

## 3.2. Board Member Reports

- Ms. Napoles is still working on Mr. Gross' evaluation.
- Mr. Croll is working with Ms. Amity Sandage and a program which involves current teachers and student teachers to develop field-based curriculum. The program is starting with secondary education but will be expanding to elementary.
