3.1. Superintendent Report

The building project final details are getting wrapped up. Inside Education came and had lunch with FoodLab. Environmental Education Initiative provides free curriculum and training in science, which we are pursuing. Tandy Beale will be giving some visual and performing arts lessons. After reviewing relevant educational research, Bonny Doon School has gotten rid of homework. We sold the bus for \$500. The office furnace is broken. It will cost about \$1,500 to get it fixed. However, all the main building furnaces are ultimately going to need replacing. Mr. Gross went to a Special Ed. SELPA meeting. The county gave us \$5,000 worth of plumbing materials – we have to pay for the labor, which will be about \$3,700. We have a new aide, who is a credentialed special ed. teacher.

Ms. Salandro has been working on publicity. Our Facebook page and memo distribution list are getting more users. Farm-to-Table was beautiful. Everyone liked the new venue. There was some discussion about how to attract new people to the event next year.

Mr. Rhabyt went to the Invention Convention training which Brenda Payne helped organize, along with Heather McDougal and some of the teachers.

Site Council rescheduled. They have a new member to replace Ms. Salandro, who had to step down now that she is on the Board.
