8.0 DISCUSSION ITEMS (Action if Needed) 8.1 Construction Update – Roger Knapp The most recent budget for the construction came in at \$1,146,484. Our budget was closer to \$1,070,000. We are still over budget. There was discussion of various options for how to address this issue. Options include:

- Delaying building the stand-alone classroom.
- Using a portable with fewer features.
- Explore whether there are other ways the project could be made less expensive for example by interpreting code more generously.
- Other???

The Board agreed to hold a special meeting to discuss the options and meet with the architect on 5:00 p.m. Tuesday, Nov. 24.

Don reminded the board that we might be able to get county help with blacktop, etc. since the school grounds are a park after school hours.

8.2 Cannabis Cultivation Choices Committee (C4) – Don Croll

Bonny Doon School Board signed a letter to the Cannabis Cultivation Choices Committee. The question was posed whether the Pacific School Board was interested in doing the same. The Board agreed that no action was needed.

8.3 Medical Administrative Claiming Agreement – Brenda Payne

MAA. Noel had stopped participating because the paperwork had been very burdensome. They have reduced the paperwork burden, and we are now going to start participating again. The idea is to connect families with medical services such as MediCal as needed.

8.4 Raising Rate of Adult Lunches – Brenda Payne
