## 1. OPENING PROCEDURES FOR OPEN SESSION

- c. Approval of the agenda Mr. Rhabyt moved to add agenda item to be

transacted (k) regarding approval of virtual meeting for December. Ms. Napoles seconded. 2 in favor, 0 opposed, 0 abstentions, 0 absences.

## 3. REPORTS

- a. Superintendent Report
  - Santa Cruz High School swatting incident was debriefed with the superintendent council. Santa Cruz City Schools was very impressed with law enforcement response. Fire department was observed and was impressed with our last fire drill.
  - ii. Multiple staff and students are currently out with COVID.
  - iii. Rancho Las Palmas Farm-to-Table grant for \$150,000 the grant goes to the farm and pays for a truck to deliver farm produce to us, as well as for our students to go on field trips to the farm.
  - iv. Applying for \$100,000 kitchen infrastructure grant reasonably simple and we have a decent chance of getting it.

  - i. Met 11/9 and discussed the school budget
- d. Parents Club Report
  - i. Mr. Gross missed the 11/8 meeting
  - ii. Movie Night was very well attended
  - iii. Potato Night attendance was about triple what was expected
  - iv. Restarted popcorn sales
  - v. FoodLab fundraiser made just over \$6,000

Approved all of the above. Mr. Rhabyt moved, Ms. Napoles seconded. 2 in favor, 0 opposed, 1 abstention due to technical problems, 0 absences.

## 5. PUBLIC HEARINGS – Opened at 4:27

Arts, Music, and Instructional Materials Discretionary Block Grant. The plan proposes spending this one-time money on our Culinary Arts Program (FoodLab). No comments from the public. Public hearing closed at 4:28.

## 7. ITEMS TO BE TRANSACTED AND/OR DISCUSSED

- a. Approval of Board Policies, Administrative Regulations, Board Bylaws, & Exhibits
  - BP #26: Parent Involvement Approved with edits marked in red on the version in the Board Packet. Mr. Rhabyt moved, Ms. Napoles seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.
  - ii. BP #31: Patriotic Exercises Approved with edits marked in red on the version in the Board Packet. Mr. Rhabyt moved, Ms. Napoles seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.
  - iii. BP #32: School Site Councils & Site Planning Question: can LCAP replace SPSA Replace the highlighted board approval date with "on or before the last board meeting of the fiscal year". Replace the highlighted site council date with "on or before June 30<sup>th</sup>" Replace SPSA with SPSA/LCAP throughout the document. The board will consider the SPSA/LCAP at the final regularly scheduled board meeting of the fiscal year. Approved with edits as described. Mr. Rhabyt moved, Ms. Napoles seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.
  - iv. BP #33a: Nonpublic Schools and Agencies Adopt
  - v. BP #33b: Resource Specialists Adopt
  - vi. BP #33c: Transportation for Special Education Adopt
  - vii. BP #33d Caseloads for Special Education Providers Adopt with caseload # of 28
  - viii. BP #33e: Teachers Right to Request Review of Class Assignments Adopt
  - ix. BP #33g: Information on Number of Students Being Provided with Special Education Adopt

Approved all 33 a-g together with one edit as noted to 33d. Mr. Rhabyt moved, Ms. Napoles seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.

- x. BP #34: Student Records Adopt Phone # = school number, Superintendent/Principal is this designee. Records are located at the school. Staff should locate the appropriate board policy number. Approved with edits marked in red on the version in the Board Packet. Mr. Rhabyt moved, Ms. Napoles seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.
- b. 2022 CAASPP Scores Mr. Gross presented a comparison chart of our CAASPP scores compared to other Santa Cruz County school districts. The board discussed the results. Overall, our scores were about median for the county. Like other schools around the county and state, our scores have declined significantly.
- c. 2023-24 School Calendar Ms. Andrews presented two options for a school calendar for 2023-24. The board discussed the pros and cons of each option. Following discussion, the board voted to approve the version

- that ends before Memorial Day. Mr. Rhabyt moved, Ms. Napoles seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.
- d. Transitional Kindergarten Implementation Mr. Gross and Ms. Andrews proposed the following:
  - i. Enroll current Preschool students in TK who will be in K next year
  - ii. Enroll full 12-month TK cohort for 23-24, despite the fact that we won't get state funding for some of them.

Following discussion, the board approved this proposal. Rhabyt moved, Ms. Napoles seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.

- e. Immunization Report Chyna Darby, Registrar, has worked very hard to keep all families in compliance with immunization laws. Mr. Gross presented details to the board.
- f. Recreation Program Rates
  - i. \$5 for 1<sup>st</sup>-3<sup>rd</sup> grade dismissal time until 4<sup>th</sup>-6<sup>th</sup> grade dismissal time
- g. Staff Compensation Ms. Andrews presented various options for December retention stipends. Following discussion, it is the intention of the board to offer a \$500 stipend to each full-time staff member and an equivalent prorated amount to staff members whose contracts are less than 1.0 fte. This retention stipend will be applied on the December payroll and will not be creditable to either PERS or STRS. This retention stipend will be paid to all staff who started their contract on or before the first day of school and who remained employed through December 1. The board directed the staff to work with the County Office of Education to ensure that this stipend is legal and compliant with appropriate laws and retirement program requirements. Approved as described. Ms. Napoles moved, Ms. Conner seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.
- h. Art, Music, & Instructional Materials Discretionary Block Grant Plan
  - i. \$22,123/yr for 4 years to pay for Food Lab Approved with no changes. Mr. Rhabyt moved, Ms. Napoles seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.
- i. Music Program Prop 28 passed and includes a supplement not supplant requirement. As a result, Pacific will wait until next year to hire music teacher.
- j. Intra-District Transfers and Enrollment Our neighboring districts are concerned about declining enrollment and may get more cautious about approving inter-district transfers. This could pose a substantial risk to our current enrollment size and funding model.
- k. Authorizing Use of Remote Teleconferencing Provisions Pursuant to AB 361 and Government Code section 54953

Approved. Ms. Napoles moved, Ms. Conner seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.
