- No solar tubes.
- Larger portable
 - No solar tubes
- *Use reserves to pay for the \$15,000 shortfall, if necessary.*

Board Meeting Notes

11/24/15

Present: Gwyan Rhabyt, Roger Knapp, Don Croll, Ralph Le Roux, Eric Gross

Call to order: 5:14pm by GR

- 1. **Discussion of building costs:** Former budget was \$1,050,000, but part of that has been spent already. We are hoping to find \$70,000 in savings. If we switch to a wood foundation, it would save \$42,169. On the larger building \$86,169 for doing a flat roof without solar tubes. The total savings would be \$128,338. There is \$50,000 for contingency. If we kept the pitched roof on the bigger building, and didn't include the solar tubes, then the savings would be \$12,000 instead of \$74,169. Should part of the contingency money be used to close the gap of approximately \$16,000? There may be Mynt money that can be used. Ralph will follow-up on that possibility. Don will ask Randy about asking Granite Rock for a donation in kind for their work on the project. Fixing field and blacktop after construction is not included in the budget. We can ask County Parks if they can pay for the playground.
- 2. Motion to direct architect to proceed with the following changes: GR/second RK/unanimous
 - a. Small portable:
 - i. Wood foundation
 - ii. Single slope roof instead of double pitch roof
 - iii. Aluminum finish on roof
 - iv. No solar tubes
 - **b.** Larger building:
 - i. No solar tubes
 - **c.** Cover \$15,000 shortfall out of reserves (but hoping that contingency may cover it instead of general fund)
 - **d.** Release money and direct Superintendent to sign documents to begin project
 - e. Don will ask Randy to ask Granite Rock for an in-kind donation
 - f. Ralph will ask if Mynt money may be used
 - **g.** Ralph will connect Eric with County Parks Director re paying for playground after construction
- **3.** Designate Eric to select a committee to choose:
 - a. Color of carpet
 - **b.** Baseboard
 - **c.** Vinyl (bathroom)
 - **d.** Cabinetry (plastic)
 - e. Exterior Hardy Plank siding
