Board Meeting Minutes

1. OPENING PROCEDURES FOR OPEN SESSION

- a. Call to Order 4:10 p.m.
- b. Roll Call & Establishment of Quorum

- i. Gwyan Rhabyt, Board President Present
- ii. Don Croll, Board Trustee Present, left at 5:00.
- iii. Cari Napoles, Board Trustee Present

Others present: Superintendent/Principal Eric Gross, District Office Manager Elizabeth Andrews

- c. Approval of the agenda for December 21, 2021
 - i. Agenda deletions, additions, or changes of sequence: Added recruitment of new board members under discussion items and public hearing on developers fees under public hearings. Mr. Croll moved, Ms. Napoles seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.

2. PUBLIC COMMENTS - None

- a. For items not on the agenda, this is an opportunity for the public to address the board directly related to school business. The Board President may allot time to those wishing to speak, but no action will be taken on matters presented (EC §35145.5).

3. REPORTS

- a. Superintendent Report
 - i. There were 4 leaks in the main building roof during the most recent storm.
 - ii. It has been difficult to hire open positions this school year.
 - iii. Mr Gross met with State Representative John Laird: Who stated that "every district in CA is in declining enrollment." Mr. Gross debunked this claim and vigorously argued for the financial needs of the school, and also described some of our most urgent facility issues to Mr. Laird. Lawyer has drafted letter of intent to sue.
 - iv. Staff is tired. Student behavior challenges are elevated compared to past years.
- b. Board Member Reports
 - i. Ms. Napoles attended a follow-up meeting with Mr. Laird, in which he specifically stated that he heard Mr. Gross' concerns from the previous meeting.
 - ii. Mr. Croll resigned effective January 1, 2022.
- c. School Site Council Report
 - i. Still no quorum. One parent position is vacant.
- d. Parents Club Report
 - i. Met during storm & internet down for most would-be participants. Short meeting; no significant decisions.

 Croll moved, Ms. Napoles seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences

- b. Master Plan for Facilities Needs tabled
- c. Annual Board Organization Mr. Rhabyt was re-elected as president. Mr. Croll moved, Ms. Napoles seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences. Ms. Napoles was re-elected as vice president. Mr. Croll moved, Ms. Napoles seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences. The board affirmed Mr. Gross as secretary. Mr. Croll moved, Ms. Napoles seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences. The board affirmed that regular meetings will take place on the third Tuesday of each month, but no regular meetings take place in July. Mr. Croll moved, Ms. Napoles seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.
- d. Authorizing Use of Remote Teleconferencing Provisions Pursuant to AB 361 and Government Code section 54953. Approved. Mr. Croll moved, Ms. Napoles seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences
- e. 1st Interim Budget Report Ms. Andrews discussed the new, combined Recreation budget, including ELO-P, and the cafeteria budget. The board discussed fundraising possibilities. The board approved the first interim budget. Mr. Croll moved, Ms. Napoles seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.
- f. Redistricting tabled
- g. Transitional Kindergarten TK is expanding to include all students over the next few years. We are receiving some planning money. Mostly, TK will be funded by ADA. There is some facilities funding for TK, but it's hard to obtain and use. We plan to offer TK in the afternoon in the K classroom. Families could attend both preschool and TK, which will help keep preschool enrollment full.
- h. Superintendent/Principal per diem rate the board discussed the possibility of establishing a per diem rate for the Superintendent/Principal. The board decided to continue discussing the issue next meeting after gathering more information.
- School Calendar The board discussed a draft of the 2022-23 school calendar.
- j. Recruitment of new Board members Mr. Gross recruited Diana Conner, who has volunteered as a tutor for Pacific School students, and served as

an aide and classified substitute. Mr. Rhabyt recommended that the board interview her at the next board meeting.
