### **Board Meeting Minutes**

#### 1. OPENING PROCEDURES FOR OPEN SESSION

- Call to Order 4:05 p.m.
- Roll Call & Establishment of Quorum
  - Gwyan Rhabyt, Board President Present
  - Don Croll, Board Trustee Present
  - Cari Napoles, Board Trustee Present

Others present: Superintendent/Principal Eric Gross, District Office Manager Elizabeth Andrews, Preschool Teacher Stacey Reynolds

- Approval of the agenda for March 16, 2021
  - Agenda deletions, additions, or changes of sequence

Approved with no changes. Ms. Napoles moved, Mr. Rhabyt seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.

#### 3. REPORTS

- Superintendent Report
  - Work Day: 12 people beautified landscaping led by Bill Henry
  - Project SERV grant application for counselor made it to round 2
  - Met again with Outdoor Learning Initiative team; assessment included
  - More superintendent drama:
    - 3...1. 4 retiring: Happy Valley, Mountain, & SLV
    - 3...2. 1 fired, then reinstated PVUSD; board refused to pay legal bill b/c president was not authorized to incur expense
  - Counselor began work; already has 8 on caseload, max of 12
  - Excluded again from Biden's rescue plan, just like Trump's rescue plans, due to the title 1 formula. Mr. Gross has been advocating with various officials about this issue.
  - Joining Cayla J. vs CA lawsuit re fair funding of schools (COVID relief used Title I allocation formula & being funded on 2019-20 ADA when we grew by about 25% in 2020-21)
- Board Member Reports
  - Ms. Napoles attended a meeting with Anna Eschu and expressed our frustration with not receiving COVID money due to the title 1 funding formula.
  - Mr. Croll advised Mr. Gross to continue his advocacy efforts around this issue
  - Ms. Napoles reported that Pajaro got a large grant to create a FoodLab-like program.
- School Site Council Report
  - Met 3/10/21 to review LCAP annual update
- Parents Club Report
  - Met 3/9/21 close to fundraising goal with a few events left to go

Approved with no changes. Ms. Napoles moved, Mr. Rhabyt seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.

• Second Interim Budget Report – Called to order 4:26 p.m. There were no public comments. Hearing closed at 4:27.

#### 7. ITEMS TO BE TRANSACTED AND/OR DISCUSSED

- Approval of Board Policies, Administrative Regulations, Board Bylaws, & Exhibits - None
- Salary Schedules for classified staff Ms. Reynolds described the history of the preschool teacher pay scales. Some years back there was a teacher an associate teacher. These two pay scales were combined to create the preschool co-teacher salary schedule. Ms. Reynolds would like to request that we return to something more like that model, with a lead teacher or site supervisor pay scale that is higher than the existing preschool teacher (previously called preschool co-teacher) pay scale. There could also be an associate teacher pay scale that might be lower than the current teacher pay scale.

Following discussion, the Board directed the District Office Manager to research the market rate for lead preschool teachers in Santa Cruz and to model expenses for various staffing scenarios for the Board to consider.

Per the written request of Food Service Director Emelia Miguel, the Board reviewed the pay scales for the Cafeteria Aide and the Food Service Director. The Board concluded that both positions are being paid roughly comparably to other employees engaged in similar work in the county, and also that the pay is as much as the school can afford at this time.

- Second Interim Budget Report
  - Ms. Andrews briefly presented the 2<sup>nd</sup> interim budget.
- Enrollment Lottery
  - Nearly full w/ waitlists at most grades
  - HS has enough enrollment to continue as a 3<sup>rd</sup> program offering
  - The Board discussed Parent Kyle Robertson's concern regarding the priority of out of district preschool students and out of district siblings of enrolled students. Mr. Robertson would prefer that siblings receive priority over preschoolers. The Board decided to continue with the existing system which is that both groups are equally weighted.
- Reopening
  - All but 2 staff vaccinated with at least 1<sup>st</sup> dose, most with 2<sup>nd</sup> dose
  - 2 mornings/week: K-3<sup>rd</sup> began 3/8; 4<sup>th</sup> began 3/15, 5<sup>th</sup>/6<sup>th</sup> began 3/23
  - 119 respondents: 44.5% of surveyed parents want to return to in-person; 23.5% do not; 32% "maybe"
  - Extending to 2 full days after spring break
- Work Calendars for Staff Approved with no changes. Ms. Napoles moved, Mr. Rhabyt seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.
- 2021-22 Independent Study, Home Study, and 5-Day Programs The Board discussed the pros, cons, and implications of creating single-grade level classrooms with both IS and 5-day students, or all three programs, in each classroom. IS students would attend M, Tu, Th. Mr. Rhabyt observed that this

approach, if HS students were included, would make next year much smoother as families wanted to switch between programs depending on COVID conditions. Mr. Croll observed that it would make sense to do it as a trial for the 2021-22 year. The Board directed Mr. Gross to discuss the concept with the staff.
