7. ITEMS TO BE TRANSACTED AND/OR DISCUSSED

- a. Construction Projects:
 - i. Debt Issuance Approval
 - 1. Delay loan until we have a construction bid that we can accept
 - ii. Select Winning Construction Bid
 - 1. Only 1 bid submitted
 - 2. Roof = \$1,455,000
 - 3. TK/K = \$2,145,000
 - 4. Total = \$3,600,000
 - 5. Absolutely no way we can accept this bid
 - 6. Two ways we can move forward at this point:
 - a. Reopen bids with lower standards for the type of contractors who can bid these contractors might not be familiar with all the paperwork involved
 - b. Pursue lease-leaseback creates a better relationship with

contractor but takes longer – might have to start construction in August (which is when school starts)

- 7. The board discussed the pros and cons of the above two options. Following the discussion, the board:
 - a. Rejected the one bid we received. Ms. Napoles moved, Mr. Rhabyt seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absence.
 - b. Instructed the Superintendent to reopen the bidding process, and decline, for now, the lease-leaseback option. Ms. Napoles moved, Mr. Rhabyt seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.

iii. Hazardous Materials Report

- 1. Asbestos in roof and floor tiles will require a subcontractor to mitigate
