4.0 PUBLIC COMMUNICATIONS

A number of people addressed the board regarding Bill SB277, which would potentially eliminate the personal beliefs exemption for vaccines. Points raised:

Current vaccination rate is near an all-time high. Current law requires people to discuss vaccination with their doctors before getting a personal belief exemption. This law only went into effect a couple of years ago, and so far has resulted in higher vaccination rates. Every state that has enacted a similar law has also seen increases in vaccination rates.

The trigger for this bill was the measles outbreak in Disneyland, which affected 24 school-age children, and resulted in no deaths.

Pertussis is affecting vaccinated children at least as much as unvaccinated children.

Only 2.5% of children state wide have personal-belief exemptions.

Under the proposed law, students can be banned from school even if they have not been vaccinated for non-communicable diseases, such as tetanus or hepatitis B.

Medical exemptions are very difficult to obtain, even now, and most doctors recommend just using the personal belief exemption.

The proposed legislation would ban unvaccinated students from attending school, which could affect school enrollment. Families who are opposed to vaccines and can manage to home school can retain their medical options, while families who cannot afford to home school will lose their medical options, creating economic disparity.

The proposed bill will require schools to pay for special services for students with IEP, and potentially have to pay for home visit services. Since independent studies has to be an approved appropriate mode for a student with an IEP, it could put schools in an impossible legal tangle.

Would have negative effects on English language learners. It could be challenging for these students to get the English exposure they need in a home-study environment.

Alternative plans exist. For example, collect more complete vaccine information. Are people opting out of chicken pox or measles? If after collecting better data, you are able to identify specific communities and diseases that pose a public health concern, you do a public-outreach campaign combined with free/low cost/convenient vaccine clinics. Finally, it would be very helpful to do more research about why some children have negative reactions to vaccines. It is possible that there is a genetic factor that can predict these negative reactions, which could improve vaccine safety.

The current bill is vague and has strange legal implications for schools. The speakers advocate referring the bill to the education committee and/or other steps to both slow down the passage of the bill and revise it to better address the various concerns and issues.

Several amendments were proposed over the weekend.

The people present at the Board meeting were not advocating for Board-level action, but informing the Board and Superintendent as individuals.
