- a. Superintendent Report
 - i. Counseling: Project SERV & SC Community Foundation grants both received. Together, will pay for two years of counseling services for students. We are in process looking for a counselor.
 - ii. Replaced rusted fence on Eastern (Life Lab) side of playground.
 - iii. Four aides and a few other staff/independent contractors are not returning next year for various reasons. (3 moving, 2 had told us they were only committing for 1 year, 1 retired, and 2 were independent contractors that decided not to renew their contracts.) In addition, two music teachers declined our offer.
 - iv. Did not receive County CORE grant for \$25,000 (\$19,000 for many years). Mr. Gross has requested the feedback on the application.
 - v. Application to increase CSPP slots by 4 students rejected. We received feedback on that application too. In addition, the CSPP program eliminated the ¾ day reimbursement rate, so we are getting reimbursed at the lower ½ day rate.
 - vi. Need to hire school psychologist, Mr. Gross is working on it.

 - i. No decisions have been made by the legislature yet regarding a universal transportation requirement.
