The Board discussed the current salary scales and possible impacts of minimum wage increases and other forms of raises. The Board also discussed parcel taxes and possible uses of the Teacher Enhancement Donation money.

Following discussion, the Board decided not to make any further salary schedule changes (beyond the previously approved increase to the aide scale to address minimum wage changes) and to consider giving a one-time bonus in the fall after various budget impacts are clearer. Mr. Croll moved, Ms. Napoles seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.

Following discussion, the Board agreed to give the teachers two professional development days for the purpose of implementing the FOSS science curriculum. Mr. Croll moved, Ms. Napoles seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.
