Mr. Gross and Ms. Andrews presented details of a revised distance-learning plan for Kindergarten through sixth grade. Mr. Gross noted that the application process for a waiver so that schools could open for in-person learning is not currently available to schools in Santa Cruz, and may not be available for the foreseeable. The County Health Officer is recommending that we plan for online learning only for K-6 for all of 2020-21.

The revised distance learning plan treats all K-6 students (5-day, home study, independent study) as the same, with no differences between programs. Most teachers would have only a single grade level of students. All students would have a choice for each subject area to engage in the teacher's classes and assignments or to pursue family-designed curriculum. If choosing family-designed curriculum, students would need to provide one work sample in the given subject area per week. In addition, all students would complete a very short form about their academic activities each day.

The preschool reopening plan is to reopen for in-person preschool, with two separate classrooms of 12 students, 1 teacher, and 1 bilingual aide each. Both groups would meet entirely or almost entirely outside.

The Board approved both the K-6 and Preschool reopening plans as described. Mr.

Rhabyt moved, Mr. Croll seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.
