Mr. Gross reported that he has already worked far more days than his contract.

LCAP: There will not be a one year 20-21 Local Control Accountability Plan but rather a Learning Continuity and Attendance Plan, submitted by all LEA's by 9/30/20. The template is set to be available by 8/1/20. By 10/30/20 the COE may submit recommendations and amendments. By 12/15/20 LEAs will adopt a Budget Overview for Parents.

ADA: According to School Services: "The signing message also highlights the provision in SB 98 that provides local educational agencies (LEAs) with an average daily attendance (ADA) hold-harmless for 2020–21, but stipulates that the state will not fund any growth experienced during the fiscal year, meaning that the ADA for an LEA is effectively locked in through this hold-harmless provision whether or not their ADA declines or grows. The Governor's message states that by not funding growth, "families enrolled in those schools may be displaced, with impacts exacerbated by the uncertainties caused by COVID-19." The Governor requests the Legislature to pursue solutions for these potential disruptions within the coming weeks, meaning that we may see some clean-up language in a bill later this summer that addresses this issue."
