- 7. ITEMS TO BE TRANSACTED AND/OR DISCUSSED
 - a. Construction Projects Update
 - i. Public Contract Code § 20925 provides, "The board shall have the right to reject any and all bids *not suitable to the best interests of the district*. In its discretion, the board may readvertise for new bids or negotiate an offered bid, if it is the sole bid received and the negotiated price does not exceed the offered bid for the work as advertised. If two or more bids are the same and are the lowest, the district board may accept the one it chooses. If no bids are received, *the district board may proceed to complete the project by force account or contract without further compliance with this article*" (emphases added).
 - ii. As you can see, the District has several options when it either receives no bids or (as in the situation you have described) only one bid was received that was "not suitable for the best interests of the district." At that point, the District is relieved from "further compliance with this article" (i.e., the bidding requirements). After all, bidding is not free; it takes staff time to create the bid documents, and the failure of the bidding process does not mean that the District must forego the project. Instead, you can either use your own labor forces to complete the project (if it is construction) or you can proceed with soliciting proposals from a

- contractor or vendor (as the case may be) and, if necessary, negotiate a purchase/construction that you believe will satisfy the District's needs.
