- Superintendent Report
  - State is considering paying schools by ADA but no decisions have been made. Charter schools are suing.
  - We received learning loss mitigation funds of about \$61,000.
- Board Member Reports
  - Mr. Croll reported on several comments he has heard from parents.

- Parents Club Report
  - Met 8/11/20
  - Drive for Schools is back on and being run by the Boardwalk
  - Approved \$13,000 budget for 2020-21
    - o \$6,000 Life Lab
    - o \$5,000 Library
    - o \$2,000 Operations & Staff Appreciation

Mr. Gross observed how dramatically lower Pacific's tax base is compared to other smalls. Approved all items with no changes. Mr. Croll moved, Ms. Napoles seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.

#### 7. ITEMS TO BE TRANSACTED AND/OR DISCUSSED

- Approval of Board Policies, Administrative Regulations, Board Bylaws, & Exhibits - None
- ConApp Approved with no changes. Mr. Croll moved, Ms. Napoles seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.
- Report on 1st Week of School
  - Enrollment K-6 = 136 (last year was 109), including 63 new students
    - 7...1. 2 families dropped to home school
    - 7...2. 1 family insisting on retention and withholding her kids from attending
  - Internet connectivity:
    - 7...1. 1 parent upset b/c she thought her kids weren't connected, but their family actually was, she just didn't realize it
    - 7...2. 1 family got a Verizon hotspot from SCCS
  - About 35 lunches served per day during the first 3 days of school
  - We still need more chromebooks (which are backordered), and textbooks are slow to come in. Some online programs are not up and running yet either.
- Learning Continuity and Attendance Plan
  - The Board reviewed the draft and asked a few clarification questions. Approval is scheduled for next month.
- Approve Interagency Agreement with BDUESD re Providing Meals to BDUESD Students.
  - This allows Bonny Doon students to pick up food from Pacific and provide us with their students' free and reduced price lunch status for billing purposes. We are pursuing a similar agreement with Santa Cruz. Approved with no changes. Mr. Croll moved, Ms. Napoles seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.
- Preschool Budget & Staffing
  - 8 students attending in person; 12 online
  - Stacey Reynolds reported on the details of enrollment and her two programs in person and distance. The preschool had a successful soft opening last week.
  - S.C. County CORE program already announced a 10% cut for preschool funding next year
  - Ms. Reynolds requested an increase to aide hours to support continuity of staffing and new safety needs.
  - The Board and Ms. Reynolds discussed the preschool budget and staffing this year and into the future.
  - Following discussion, the Board recommended that the superintendent offer increased hours for one preschool aide on a temporary basis for the next two months and revisit the issue in October.
