The state has announced a new LCAP format that asks questions about our distancelearning plan and our reopening plan. The new version will be due in September.

7. ITEMS TO BE TRANSACTED AND/OR DISCUSSED

- Approval of Board Policies, Administrative Regulations, Board Bylaws, & Exhibits Tabled
- Enrollment Has been a moving target. Overall, enrollment has increased, but with a lot of fluidity. Current enrollment = 140. We are currently planning one

teacher per grade level for every grade except $5^{\text{th}}/6^{\text{th}}$. There are also some offers pending and some students on the waitlist.

- Reopening Plans for Elementary and Preschool Enrollment in preschool ended up being disappointing. We do not have enough enrollment for the second classroom. We are going to offer a distance learning preschool option. The Board discussed the budget impacts. Not hiring a second teacher definitely saves costs.
- Learning Continuity and Attendance Plan Our distance learning plan is holding up reasonably well so far, although we did make a few adjustments.
- Increase prices of meals:
 - Adults: from \$5.65 to \$6.00
 - Students: from \$3.60 to \$3.75
 - Staff: from \$4.25 to \$4.50
