1. OPENING PROCEDURES FOR OPEN SESSION

- Approval of the agenda for September 15, 2020
 - Agenda deletions, additions, or changes of sequence

Mr. Croll moved, Ms. Napoles seconded. Approved with no changes. 2 in favor, 0

opposed, 0 abstentions, 1 absence.

2. PUBLIC COMMENTS

Ms. Martinez expressed concern about logistical issues with distance learning, specifically:

- Provide a warm-up or opener before direct instruction so that if you are join a few minutes late you don't miss important instructions
- Teachers in different grade levels are using very different platforms, so that it is hard for parents with two or more students to track everything
- It is very hard to locate class schedules
- It is confusing for parents, especially if they have multiple students, work full time, are not native English speakers, and/or not tech-savvy

She also expressed the desire to know more about how students are being assessed. She suggested that some parents, principal, and teacher leaders meet to figure out ways to smooth out some of the kinks.

Ms. Andrea Riordan mentioned that some students finish early and don't have a clear project that they are supposed to work on next.

Ms. Dona Bumgarner also noted the differences between different teacher's approaches and systems. She also noted that it is very difficult for her to track and understand all of the aspects of her student's distance-learning program.

- Report on CZU Lightening Complex Fire and Evacuation
 - 66% (94/142 doesn't include 20 preschoolers) students evacuated automatically designated as homeless & free lunch
 - Census outreach efforts have been hampered by the fire and evacuations
 - Disaster Cleaning Company

- Governor's Blueprint for a Safer Economy
 - New State Health Officer favors reopening
 - Rating on 4-tiered system
 - Stanford may supply adequate testing capacity would cost \$77 per test, not clear who pays
 - Teachers nervous about opening and about yo-yo effect of opening & closing. Teachers do not want to open at this time.
- Approval of Change to Leave Policy
 - Evacuation Leaves: All staff members are entitled to 5 days paid leave for being evacuated (per evacuation event) and 10 additional paid days for total home loss (per event). All evacuation and/or home loss leave must be taken during 2020-21, and this policy will expire June 30, 2021.

Approved with no changes. Mr. Croll moved, Ms. Napoles seconded. 3 in favor, 0 opposed, 0 abstention, 0 absences.

• Assumption of Risk

If staff bring their own children to the Pacific School campus they accept all responsibility for risk of contracting COVID-19, and not hold Pacific Elementary School District liable. Approved with the modification that all instances of "son or daughter" would be changed to "child". Mr. Croll moved, Ms. Napoles seconded. 3 in favor, 0 opposed, 0 abstention, 0 absences.
