# **Board Meeting Minutes**

#### 1. OPENING PROCEDURES FOR OPEN SESSION

- a. Call to Order 4:05 p.m.
- b. Roll Call & Establishment of Quorum
  - i. Gwyan Rhabyt, Board President Present
  - ii. Cari Napoles, Board Vice President Present
  - iii. Diana Conner, Board Trustee Arrived 4:07 p.m.
- c. Approval of the agenda Approved with no changes. Ms. Napoles moved, Mr.
  - Rhabyt seconded. 2 in favor, 0 opposed, 0 abstentions, 1 absence.
    - i. Agenda deletions, additions, or changes of sequence

#### 2. PUBLIC COMMENTS - None

#### 3. REPORTS

- a. Superintendent Report
  - i. County-wide attendance campaign. One small thing will be rolled out per month county-wide.
  - ii. Potato Night 100+ attendance
  - iii. Special Programs (advanced math rotations, Music, GATE, Library, tutoring) began 8/21
  - iv. Hazardous materials inspection: took 5 items to landfill, rest passed
  - v. Williams inspection: 2 minor items (extension cord, Universal Complaint Policy posting) fixed same day, rest passed
  - vi. County Assessor: after CZU, 7.6% houses rebuilt; 33.8% permits issued
- b. Board Member Reports Ms. Conner pointed out an article that discussed the sharp decline in enrollment in Santa Cruz County. (We are the only district in the county that has grown.)
- c. School Site Council Report Met, two parent members are changing from last year. Mr. Gross provided an overview of the purpose and role of the site council and the demographics of the school.
- d. Parents Club Report Met, 3 of the 8 people on the call had a 6<sup>th</sup> grader at the school, and some of the others had 5<sup>th</sup> or 4<sup>th</sup> grade. There were 2 younger parents on the zoom.

- **a.** Resolution # 2024-1 Sufficiency of Instructional Materials Approved with no changes. Ms. Napoles moved, Mr. Rhabyt seconded. e in favor, 0 opposed, 0 abstentions, 0 absences.
- **b.** Resolution # 2024-2 Gann Spending Limit Approved with no changes. Ms.

Napoles moved, Mr. Rhabyt seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.

**c.** Resolution #2024-3 Lease-Leaseback Contracts – Mr. Gross has been advised that this is the only way to move forward with construction projects. Approved with no changes. Ms. Napoles moved, Mr. Rhabyt seconded. e in favor, 0 opposed, 0 abstentions, 0 absences.

## 7. ITEMS TO BE TRANSACTED AND/OR DISCUSSED

- a. Construction Projects Update
  - i. Hire Construction Manager? 19six recommends; contractor doesn't. Mr. Gross met with one today, who will be providing a bid soon.
  - ii. Following back and forth with lawyers, it was determined that we cannot negotiate directly w/ contractors, instead we are negotiating with contractors on lease-leaseback arrangements.
  - iii. There are two big contractors that seem very interested, given a construction window of the summer of 2024.
  - iv. Loan (high rates now) vs Bond (1 bond @ 66% passing rate or 2 smaller bonds @ 55% passing rate) to pay for construction. The board discussed this option. Mr. Rhabyt pointed out that there are lot of extra costs to bonds.
- b. Auditor Selection
  - i. Reviewed 3 accounting firms:
    - 1. Clifton Larson Allen (most expensive)
    - 2. Harshwal (selected)
    - 3. Robertson (20-year relationship; under contract through this year, has not been very responsive or on time)
- c. Board Policies & Administrative Regulations
  - i. AR 3311.2 Lease-Leaseback Approved with no changes. Ms. Napoles moved, Mr. Rhabyt seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences, it was noted that we would renumber this after approval.
  - Preschool Admissions Priorities PESD 206 Approved with no changes. Ms. Napoles moved, Mr. Rhabyt seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.
- d. Williams Inspection They look at facilities, textbooks, and teacher credentials. Findings were summarized above.
- e. Job Classifications and Seniority Lists -
- f. Extended Learning Opportunities Program Plan (ELOP) Approved with no changes. Ms. Napoles moved, Mr. Rhabyt seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.

  - i. Unaudited Actuals Ms. Andrews discussed the budget. Overall, it is on track, except deficit in preschool & approval of room 6 replacement
  - ii. GANN Appropriations Report
  - iii. Education Protection Account Report
  - iv. Special Education Maintenance of Effort

Approved with no changes. Ms. Napoles moved, Mr. Rhabyt seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.

- Flag Policy Adapt the resolution from SSCS: change title, meeting date, superintendent, district name in two places. Replace specific dates for flying the flag to "during the academic year" change "fly" to "display". Omit the cover letter. Approved as described. Ms. Napoles moved, Mr. Rhabyt seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.
