- a. Superintendent Report
 - i. Pacific School had a Lockdown on 8/19 due to a hunter present on highway 1; inebriated man present near campus on 8/22 but posed no threat.
 - ii. We had a Williams audit (credentials, textbooks, facilities).
 - iii. Plans will be resubmitted to DSA by October. Approval expected by December. Construction expected in June. This timeline includes the corner portable, currently used for first grade, and replacing the roof on the main building. The second summer they would do the building currently used for preschool. The third summer the portable next to the MU would be replaced with two classrooms.
 - iv. Elections: Cari Napoles & Diana Conner were the only candidates to file by deadline, so they will be appointed in lieu of election and sworn in at Dec or Jan meeting.
 - v. Spectra matching grant for West Theater for \$1,500 towards the fifth-grade play.
 - vi. New parts have been ordered for the play structure.
- b. Board Member Reports
 - i. Ms. Napoles attended the FoodLab fundraiser. It was a lovely event and may have raised about \$7,000.
- c. School Site Council Report
 - i. First meeting held on 9/14 elect members & officers, there were actually more interested parents than slots. Parents are of younger students.

 - i. Scholastic Book Fair became a controversial topic.

- b. Approval of Board Policies, Administrative Regulations, Board Bylaws, & Exhibits
 - i. BP #01 Suicide Prevention Mr. Gross determined that other elementary districts did not adopt this policy b/c it is not required, and they are not adopting any that are not required. Following discussion, the board agreed not to adopt this policy. Ms. Napoles moved, Mr. Rhabyt seconded. 2 in favor, 0 opposed, 0 abstentions, 1 absence.
 - ii. BP #03 Sexual Harassment Approved with common sense replacements for the yellow highlights. Ms. Napoles moved, Mr. Rhabyt seconded. 2 in favor, 0 opposed, 0 abstentions, 1 absence.
 - iii. BP #11 Equal Opportunity Leave the yellow highlighted as is. Change "men or women" to "men, women, or non-binary individuals" Approved as described. Ms. Napoles moved, Mr. Rhabyt seconded. 2 in favor, 0 opposed, 0 abstentions, 1 absence
 - iv. BP #12 Teacher Assignments Outside Scope of Credential Adopt with minor fixes for our district. Approved with as described. Ms. Napoles moved, Mr. Rhabyt seconded. 2 in favor, 0 opposed, 0 abstentions, 1 absence
 - v. BP #13 Leave Laws for Certificated & Classified Employees Include 50% sub diff, district-granted COVID including care for covid-positive dependents. Approved as described. Ms. Napoles moved, Mr. Rhabyt seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.
 - vi. BP #14 Exempt Classified Employees & Fingerprinting Adopt (we don't have a merit system) Approved with no changes. Ms. Napoles moved, Mr. Rhabyt seconded. 3 in favor, 0 opposed, 0

- abstentions, 0 absences.
- vii. BP #15 Classified Employees Probationary Period Choice: 1 year option Approved as described. Ms. Napoles moved, Mr. Rhabyt seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.
- viii. BP #16 Student Promotion and Retention Leave item C and remove brackets, remove section referring to high school, parental appeals are reviewed by the Superintendent/Principal, get rid of all three bullets about obtaining remedial instruction "If a student is identified ... the district shall offer appropriate opportunities for obtaining remedial instruction." Approved as described. Ms. Napoles moved, Mr. Rhabyt seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.
- ix. BP #17 Investigation of Residency Superintendent does investigations, remove brackets, "other purposes as appropriate" and "other methods as appropriate". 30 days for parent appeal, 45 days for board response. Approved as described. Ms. Napoles moved, Mr. Rhabyt seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.
- x. BP #18 Reporting Truancy Approved as is. Ms. Napoles moved, Mr. Rhabyt seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.
- xi. BP #19 Pupil Attendance Policies 3 for both blanks is considered standard. Remove "attending jury duty" and "serving as a member of a precinct board for an election." Approved as described. Ms. Napoles moved, Mr. Rhabyt seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.
- xii. BP #27 Independent Study Approved as presented. Ms. Napoles moved, Mr. Rhabyt seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.

- e. Educator Effectiveness Plan We plan to spend almost all of the Educator Effectiveness Funding on the New Teacher Project. Plan approved as presented. Ms. Napoles moved, Mr. Rhabyt seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences
- f. Pay Rate for Certificated Teachers working in after school programs Ms. Andrews reported the information she received from the COE. Teachers paid for doing classified work get paid on the classified pay scale.
- g. Re-certify Children's Internet Protection Act (CIPA) compliance
 - i. Teachers teach all students digital citizenship
 - ii. Students sign acceptable use policy
 - iii. COE filters internet for appropriate content
 - iv. Wendy = 3^{rd} - 6^{th} grades

h. Unaudited Actuals for 2021-22 budget year – Ms. Andrews reviewed the unaudited actuals for 2021-22. Mr. Rhabyt instructed Mr. Gross and Ms. Andrews to create a plan for how much money should be moved from fund 1 to fund 17. Approved as presented. Ms. Napoles moved, Mr. Rhabyt seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences
